



## GENERAL TERMS AND CONDITIONS

When registering online on the website [www.optimal-prospect.eu](http://www.optimal-prospect.eu), acceptance of general terms "OPTIMAL PROSPECT" implies knowledge and commitment of these conditions.

The present OPTIMAL PROSPECT 2020 general terms and conditions comprise 13 articles.

- **Art.1. Organization:** The OPTIMAL PROSPECT 2020 business convention shall be organized by the Chamber of Commerce and Industry of Bourgogne - Franche-Comté (hereinafter the "Organizer") and shall be held in MONTBELIARD on 13 and 14 October 2020 at the Axone Congress Centre.  
In the likelihood of an event beyond its control or as a result of force majeure, the Organizer shall have the option of changing the dates or venue for this event, or cancel it altogether after having notified the participants.
- **Art.2. Obligations of the Organizer:** The Organizer shall only be bound by an obligation of means.
- **Art.3. Registration:** Registration for the OPTIMAL PROSPECT 2020 business convention shall only be deemed final upon acceptance of the registration by the Organizer.
- **Art.4. Termination and withdrawal: Registration shall be considered firm and final.**  
There shall be no reimbursement whatsoever should order-givers fail to attend the event on the day.
- **Art.5. Payment:** Suppliers shall be asked to settle payment upon registration, which shall serve to confirm their registration. The Organizer shall then institute the relative procedure and provide for full or partial services subject to deadlines as of this date.
- **Art.6. Reimbursement terms for buyers:** reimbursement terms for buyers are stipulated in the document "[Reimbursement terms for buyers](#)", reachable on the website [www.optimal-prospect.eu](http://www.optimal-prospect.eu) and the online buyers' registration file.
- **Art.7. Stand:** Exhibitors shall not be permitted to exhibit any materials outside or above the area of the stand attributed to them. Participants shall undertake to be present at their stand for the entire duration of the event.
- **Art.8. Insurance:** All participants shall be asked to provide justification of insurance covering civil liability as well as any damage for which they might be held responsible: notably: theft, fire, deterioration, destruction of any materials or installations. The Organizer and its insurers shall waive their right to recourse against exhibitors and their insurers. Reciprocally, the exhibitors and insurers shall waive their right to any recourse against the Organizer and its insurers.
- **Art.9. Advertising:** After registration has been accepted, the Organizer shall grant participants the right to include the following mention on their commercial and advertising documents: "OPTIMAL PROSPECT 2020 participant, 13 and 14 October 2020 - Montbéliard France – Axone Congress Centre"  
  
On the same token, participants shall authorize the Organizer to mention their participation in the said event. After registration has been accepted by the Organizer, participants shall authorize the Organizer to relay their contact details.
- **Art.10. Confidentiality:** In accordance with the legislation in force at the date of final registration, all persons having provided personal details shall have the right to access and modify the information concerning them.

- **Art.11. Model release:** By registering for the event, OPTIMAL PROSPECT 2020 participants shall authorize the Organizer to make use of their image within the strict framework of organizing and promoting events organized by the Bourgogne Franche-Comté Chamber of Commerce and Industry.
- **Art 12. Personal Data Management:** The participant is informed of the collection of personal data by the Organizer. This data are collected in order to organize and manage the event. This data processing is legally based on Article 6 of the personal data protection regulation EU/2016/679, Par. 1, point b.: performance of a contractual obligation. The recipients of this personal data are the employees of the Chamber of Commerce and Industry of Bourgogne Franche-Comté and of the Chamber of Commerce and Industry of Doubs. These data are updated annually.
